so that we will be ready.

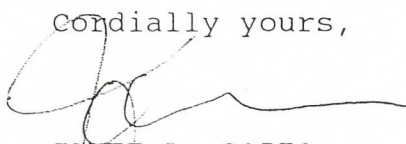
